1. GENERAL PROVISIONS

- 1.1. This regulation "On the individual rating assessment of the activities of the teaching staff of the NJSC "West Kazakhstan Medical University named after Marat Ospanov" (hereinafter referred to as the University) determines the procedure for organizing and conducting an individual rating assessment of the activities of the teaching staff at the NJSC "West Kazakhstan Medical University named after Marat Ospanov" (hereinafter referred to as the Rating)
- 1.2. This regulation determines the rating of the main staff of the University from among those holding teaching positions to assess the results of their scientific and pedagogical activities.
- 1.3. Faculty members of theoretical and clinical departments who have continuous scientific and pedagogical experience of at least one year at the time of participation in the Ranking can take part in the Ranking.
- 1.4. Ratingis based on the use of KPI (Key Performance Indicator) key performance indicators.
- 1.5. The Rating's KPI indicators can be adjusted annually in accordance with the University's development goals and the emergence of new tasks.
- 1.6. The responsible structure for organizing and conducting the Rating is the Strategic Development Department.

2. GOALS AND OBJECTIVES OF CARRYING OUT THE PPP RATING

- 2.1. The purpose of the Rating: activation and stimulation of all types of professional activities of teachers, focused on improving the quality of the educational process, scientific and clinical activities, and the image of the University.
- 2.2. Rating objectives:
- > creation of a system of internal analysis of the effectiveness of the activities of teachers and departments of the University;
 - > creation of an information database of teachers' activities;
- > moral and material stimulation of the growth of qualifications, professionalism, productivity of pedagogical, scientific and clinical work, development of teacher initiative.
- 2.3. Basic principles of the Rating:
 - > compliance of the content of the assessment with the priority areas of development of the University;
 - > objectivity and reliability of the information received;
 - > competence and collegiality of decisions made.

3. TECHNOLOGICAL REQUIREMENTS FOR RATING:

- 3.1. The Rating uses the optimal number of KPI indicators that characterize the activities of each employee. Indicators are feasible, objective and measurable
- 3.2. The KPI Rating indicators take into account the qualification level of the teacher, his pedagogical, scientific and methodological, scientific, social activity, and the results of clinical work for the reporting year.
- 3.3. An information database of the activities of teachers participating in the Ranking is formed by automating processes

4. PROCEDURE FOR ORGANIZING THE RATING OF PPP

- 4.1. The calculation period for determining the Rating is a calendar year: from January 1 to December 31.
- 4.2. In the period from June 1 to June 31 of the reporting year, interim monitoring of the implementation of indicators is carried out.
- 4.3. The final results of the Rating are summed up before January 31 of the reporting year.

- 4.4. The final rating of teachers is presented in the form of a table using a descending point ranking system according to the algorithm for calculating indicator points. The results of the Rating are formalized by the conclusion of the Rating Commission and submitted to the meeting of the University Board for consideration.
- 4.5. The results of the Rating are determined throughout the reporting period and are formed according to the following sections:
 - ➤ Educational activities:
 - Scientific projects;
 - > Scientific publications;
 - Scientific developments;
 - > Scientific guidance;
 - > Competencies;
 - > Student guidance;
 - > Image work. Academic mobility;
 - Clinical work (for clinical departments).

Sections of the Ranking can be adjusted, changed and supplemented depending on the directions of the University's activities, ways to achieve its goals and solve problems.

4.6. Due to priorities, the sections of the Rating are not equivalent in terms of weighting coefficients and point values for the implementation of indicators (Appendix B).

5. RATING IMPLEMENTATION MECHANISM

- 5.1. The form for filling out individual KPIs is presented in Appendix A.
- 5.2. At the beginning of the reporting year, the Rating participant independently plans its activities for the reporting period by entering planned quantitative indicators in accordance with KPI indicators in the "Planned value" column of each section.
- 5.3. During the reporting year, the Rating participant strives to achieve the set targets, collects supporting documents of the work performed in accordance with the criteria of supporting documents (Appendix C).
- 5.4. At the end of the reporting period, based on the work performed, the Rating participant enters a quantitative value in accordance with the KPI indicators in the "Act of Completion" column of each section.
- 5.5. According to the "Supporting Documents" column, the Rating participant attaches supporting documents for completed indicators in accordance with the Criteria for Supporting Documents.
- 5.6. According to Appendix 1, a formula has been developed for calculating the rating score, the final value of each section of activity and the final value of the entire rating.

<u>Rating score</u> for the implementation of each indicator, the KPI of each section of activity is calculated by multiplying [Act of implementation] x [Points of each indicator].

<u>Total value</u>of each activity section is calculated by [summing all rating points] and multiplying the resulting amount by [section weighting coefficient].

Overall final value of the Ratingwill be equal to the sum of all [total values of activity sections].

- 5.7. Each Rating participant enters information into the database independently and bears personal responsibility for the information provided.
- 5.8. For the purpose of monitoring the PPP ratingAt the stages of its implementation, the reliability of the entered information is monitored. The reliability of the information presented is determined on the basis of objective evidence (supporting documents) on the implementation of each KPI indicator, which is checked and confirmed by the relevant responsible structures:

- 5.9. To make a final decision based on the results of the Ranking, a special commission is created at the University from among representatives of the DAR, DPR, deans, the department of strategic development, the legal department, the department of economics and strategic planning, the composition of which is approved by order of the Chairman of the Board-Rector of the University.
- 5.10. The Strategic Development Department submits the results of the Final Rating Values for each teacher to the Commission for discussion. Through discussion, the Commission determines and approves rating participants using a descending point ranking system.
- 5.11. The results of the commission meeting are documented in minutes, certified by the signatures of the commission members and transferred for a subsequent decision to University Board.

6. PAYMENT OF INCENTIVE PREMIUM

- 6.1. Based on the achievement of key rating indicators, employees are provided with a one-time bonus payment.
- 6.2. The bonus scale and the amount of bonus payment are approved by the decision of the University Board.
