# Admission procedure for applicants (foreign citizens) to the Non-Commercial Joint Stock Company ''West Kazakhstan Marat Ospanov Medical University''

### GENERAL PROVISIONS

1.1. These rules of admission of foreign citizens to the to the Non-Commercial Joint Stock Company "West Kazakhstan Marat Ospanov Medical University " (hereinafter - University) developed in accordance with the Order of the Minister of Education and Science of the Republic of Kazakhstan dated October 31, 2018 No. 600 "Model rules for admission to educational organizations implementing educational programs of higher education" of the Republic of Kazakhstan (with amendments and additions as of June 08, 2020 No. 237) higher educational institutions of the Republic of Kazakhstan are accepted foreign citizens and stateless persons with secondary general, primary vocational, secondary vocational and higher vocational education.

1.2. Admission of foreign citizens to the University's specialties under bachelor's degree programs is carried out under contracts with payment of tuition fees by individuals and (or) legal entities in accordance with the procedure established by the Ministry of Education and Science of the Republic of Kazakhstan.

1.3. Stateless persons permanently residing in the Republic of Kazakhstan and persons of Kazakh nationality who are not citizens of the Republic of Kazakhstan are granted the right to receive free higher education on a competitive basis in accordance with the state educational order, if they receive this level of education for the first time.

1.4. The right for foreigners to receive free higher education on a competitive basis in accordance with the state educational order is determined by international treaties of the Republic of Kazakhstan.

1.5. Admission of foreign citizens to study at the University on a fee basis is carried out in the form of an exam conducted by admission or exit commissions.

1.6. Admission of foreign citizens is carried out in accordance with direct agreements (contracts) concluded by the University with foreign citizens with payment of tuition fees and on conditions determined by the admission rules.

1.7. Admission of foreign citizens is carried out according to the license of the University for the right to conduct educational activities in the relevant specialties and providing for the issuance of educational documents of its own sample.

1.8. Foreign citizens with secondary general, secondary vocational (post-secondary), higher (higher professional) education are accepted to the University.

1.9. The form and procedure of entrance examinations for applicants from abroad is determined by the University independently.

1.10. If a foreign citizen provides information that does not correspond to reality, the University has the right to return the documents to him and expel him from the university without returning the funds deposited.

### 2. Admission and enrollment of foreign citizens

2.1. According to the Standard Rules of Admission to educational organizations implementing educational programs of higher and postgraduate education, admission of foreign citizens to study in the organization of higher and postgraduate education on a fee basis is carried out based on the results of an interview and an essay conducted by the University admissions committee during a calendar year. At the same time, enrollment of foreign citizens is carried out in accordance with the academic calendar 5 (five) days before the beginning of the next academic period.

2.2. Admission to study in groups of educational programs of higher education that require special training, including in the field of education "Health and social security (medicine)", is carried out taking into account the results of special examinations.

2.3. The applicant submits an online application through the electronic portal tester.zkgmu.kz and attaches the necessary documents in JPG format (INSTRUCTION appendix):

- identity document or passport;

- certificate / diploma of completion of secondary school / college or university.

2.4. If necessary, the admissions committee has the right to request additional documents. After checking the documents for compliance with the requirements online by the admissions committee, a foreign citizen is allowed to interview and test by sending a login and password to e-mail. Within three days after sending the login and password for testing, the applicant must pass the test, after the specified period, access to testing will be closed. A foreign citizen is granted 3 (three) days.

2.5. The organization of the interview is carried out by the admission committee of the University. For the period of the entrance examinations, an examination commission is created from among the university staff.

2.6. Foreign citizens wishing to study in English in the educational programs of higher education in the field of education "Health and social security (medicine)" are tested online in the following subjects: general knowledge and logic, biology, chemistry, physics and mathematics in the scope of secondary education curricula, as well as and they write an essay answering 3 (three) questions. An online interview is conducted to determine the level of English language proficiency and communication skills.

2.7. Russian Russian and Kazakh foreign citizens wishing to study in the educational programs of higher education in the field of education "Health and social security (medicine)" are interviewed or tested online or directly at the University in

three subjects - biology, chemistry and the language of instruction (Kazakh or Russian).

2.8. Enrollment of foreign citizens is carried out in accordance with the results of the entrance exam (those who have scored the minimum level according to the results of testing, essays and interviews -105 (one hundred and five) points out of 150 (one hundred and fifty)).

2.9. To the admissions committee, foreign citizens attach to the application for admission:

1) the original of the document on education;

2) an appendix to the document on education (original) with the following information: academic disciplines, final grades received, other components of the educational process;

3) notarized translation of the document on education and its appendices into the state and/or Russian language;

4) a notarized copy of the applicant's identity document with translation into the state and/or Russian language;

5) a copy of the license of the educational institution or the certificate of accreditation of the educational institution that issued the document on education, with the exception of state-issued documents on basic secondary, general secondary education, certified by the seal of the educational institution;

6) a notarized translation of a medical report on the state of health confirming the possibility of studying in the conditions of the climate of the Republic of Kazakhstan and relevant educational institutions, certified by the official health authority of the country sending the candidate to study in the Republic of Kazakhstan;

7) medical certificate Form 086/y (medical certificates of mental health, absence of infectious diseases and contraindications to study at a medical university, certified by the official health authority of the sending country; certificate of absence of HIV infection, certified by the official health authority of the sending country);

8) information about vaccinations;

9) 6 photo cards measuring 3 x 4 centimeters.

2.10. Foreign citizens from visa-free travel countries (Azerbaijan, Armenia, Belarus, Russia, Kyrgyzstan, Moldova, Tajikistan, Uzbekistan, Ukraine) provide:

□ passport;

 $\Box$  migration card;

 $\Box$  6 photo cards 3 x 4 centimeters;

 $\Box$  certificate from the AIDS center;

 $\Box$  fluorography (for the first year, a copy of the medical certificate form U-086 is available).

2.11. Educational documents issued by foreign educational organizations undergo the nostrification procedure in accordance with the procedure established by law after enrollment of persons during the first semester of study. 2.12. Registration of documents for the nostrification procedure is provided by representatives of foreign students together with the Dean's Office of the International Medical Faculty of the University.

2.13. If necessary, the admissions committee has the right to request additional documents.

2.14. Registration of documents for visa support is provided by the Dean's Office of the International Medical Faculty of the University.

## 3. Tuition fees for foreign citizens

3.1. The amount of tuition fees for educational programs of higher and (or) postgraduate education is approved by the Board of Directors of the University in accordance with subparagraph 2 of paragraph 9-2 of Article 44 of the Law of the Republic of Kazakhstan "On Education".

### 4. Check-in to the hostel

4.1. Foreign citizens entering the University are provided with places in the dormitory for the period of passing entrance exams and studying at the University.


